- Supports the development and update of roadmaps in support of the Joint Implementation Frameworks (JIF) and their formal and technical sessions in Guyana and Honduras.
- Provides guidance and proposes solutions for the design, development and deployment of TLAS elements in Guyana and Honduras.
- Provides technical recommendations on projects implemented in support of FLEGT processes.
- Supports stock takes and joint assessments to inform decision-making on critical issues in FLEGT processes.
- Contributes to the Joint Implementation Committees (JICs) annual reporting.
- Supports bilateral dialogues between the EU and the partner countries, including JIC organization, and related multi-stakeholder dialogues as well as animates sub working groups.
- Conducts analyses to identify FLEGT Licensing related problems and propose solutions for a

functioning licensing scheme.

- Supports the FLEGT-ALA Facility Lead Expert with periodic progress and terminal reports for review by those units having technical, financial, and operational responsibility.
- Represents, in consultation with the FLEGT-ALA Facility Lead Expert, the Facility in international meetings and in high-level regional and national meetings and undertakes monitoring missions as appropriate.
- Performs other related duties as required.
