Our IT SMEs advise Senior Management and the different Euroclear lines of business on the concrete application of the laws, regulations, standards and codes related to IT (security), operational resilience (DORA) and digital innovation.

Acquisitions colleagues support the group M&A and partnerships strategy by means of providing regulatory due diligence on acquisition and partnership targets; they act as gatekeeper for C&E-wide engagement.

The whole team proactively engages with first line and second line stakeholders, ensures regulatory changes are identified and implemented, and provides constructive challenges when needed.
