Collaborate with R&D Digital & Tech and Central Tech, including the Cybersecurity Office (CSO), and Global Products & Technology (GP&T) stakeholders to ensure the controls proposed to mitigate the risk are appropriate for the business area, correctly implemented and adopted consistently by the business area.

Ensure review and approval of Firewall (FW) rules, reference architecture, VLAN strategy and high-level strategy for local deployment.

Assess OT vulnerabilities and prepare Cyber crisis management, OT alerts, OT responses

Manage internal network of local experts and ensure sharing of best practice and learnings in area of expertise

Ensure for new equipment commissioning projects, the definition of landscape design for computerized system(s), in respect to tech rules, but also to Data integrity and cyber security standards

Ensure identification and application of appropriate OT/Cyber Security controls for CAPEX projects in R&D Belgium
